- 4. <u>ARRIVAL TIME:</u> must be between 10:00 a.m. and 12:00 p.m. on the Sunday opening day of their term. (*We will not be able to provide transportation for arrivals after 1:00 pm*). Lunch will be provided on the bus on the way to Camp Longhorn.
